

BEACH PARKING PERMITS AND VIOLATIONS

BEACH PERMITS

Beach parking permits for CARS, GOLF CARTS, and MOPEDS will be available beginning on Memorial Day weekend. At that time ALL PREVIOUSLY ISSUED PERMITS WILL EXPIRE.

Permits will be available at the Community House Office from 1:00 p.m. to 3:00 p.m. daily for two weeks starting the Saturday of Memorial Day weekend. After the two-week period, arrangements should be made with the Property Manger, (269) 426-8348, for issuance of permits.

All permits will only be issued to those whose dues, fees, and assessments are paid in full to date.

Permits must be signed for by the property owner or a designated adult. Golf carts and mopeds must be owned by the property owner using those permits. They are not transferable. A car permit may be loaned to guests by the property owner.

Permits will be issued on the following basis:

- 1 mirror permit for an automobile per household
- 1 golf cart permit per household
- Up to 4 moped permits per household
- Parking is limited to only **one** of the above categories at any time. Any combination of the above will result in the issuance of a citation.
- 1 beach flag per household must be displayed when using the beach. These are retained by the homeowner from year to year and must display the current year's sticker.

Lost permits or beach flags will be replaced for a fee per a schedule as determined by the Board of Directors and updated from time to time. Temporary permits of short duration may be issued at the Property Manager's discretion to those who may have forgotten to bring or otherwise misplaced their valid annual permits.

BEACH PARKING AND ROADWAY VIOLATIONS

Through June 30th, parking citations will be issued for parking in a beach parking lot without a valid permit or for parking an automobile and a golf cart at the same time. The violation will be noted on the citation and copies will be filed with the Property manager. The first citation is a warning. The second citation will result in the vehicle being subject to towing at the owner's expense. Beginning July 1st, vehicles without a valid permit parked in a beach parking lot will automatically be subject to towing without prior warning.

No part of any vehicle may be parked on a paved road or right-of-way anywhere in Shorewood. This is a public safety issue as improperly parked vehicles may impede the passage of emergency vehicles. Vehicles improperly parked in a road or right-of-way are subject to immediate towing at the Property

Manager's discretion. Right-of-way includes the full platted 25- or 30-foot width of a road, not just the paved area. To do so may inhibit or block access by a public safety vehicle. Violators will be issued a warning citation for the first offense. A second violation will result in the vehicle being subject to towing at the owner's expense.

The relevant violations will be noted on the citation and copies filed with the Property Manager.

MEADOW OVERFLOW PARKING

For owners or renters unable to park all their vehicles at their house, overflow parking is available in the meadow adjacent to the front entrance of Shorewood.

Vehicle owners must check in with the Property Manager and receive a parking registration form. They will fill in the form with vehicle owner name, cell phone number, Shorewood address and beginning and ending dates for parking in the Meadow. The form should be prominently displayed on the dashboard of the vehicle.

Failure to display a fully completed registration form will result in the vehicle being subject to towing at the owner's expense.

A parking registration form is NOT valid for parking in a beach parking lot.

Overflow parking in the Meadow is NOT available the days of Summerfest and Grill on the Green.
